### 3. ALL INDIA QUOTA

#### 3.1 Quota for Veterinary Council of India (VCI) - BVSc & AH

**FIFTEEN PER CENT (15%) OF THE TOTAL NUMBER OF SEATS** in BVSc & AH degree is reserved for the candidates selected by the Veterinary Council of India, New Delhi (for further details, contact VCI).

#### 3.2 Quota for Indian Council of Agricultural Research (ICAR) - BTech (Food Technology and Dairy Technology)

**FIFTEEN PER CENT (15%) OF THE TOTAL NUMBER OF SEATS** in BTech (Food Technology and Dairy Technology) degree is reserved for the candidates selected by the ICAR, New Delhi (for further details, contact ICAR).

### 4. TAMIL NADU STATE QUOTA

#### 4.1 ELIGIBILITY FOR ADMISSION

Candidates satisfying the eligibility conditions given below as on the last date of submission of online application are eligible to apply. Passing the qualifying examination or changing the religion after the last date of submission of online application shall not be considered.

##### 4.1.1 NATIVITY

- i. Candidates should be an Indian Citizen and **Native of Tamil Nadu State**.
- ii. Candidates who have passed VIII, IX, X, XI and XII Std. in Tamil Nadu are eligible to apply. **They need not submit Nativity Certificate.**
- iii. **The candidates who are native of Tamil Nadu and have passed any of the VIII, IX, X, XI and XII Std. or their equivalent examinations from schools situated outside Tamil Nadu should enclose Nativity Certificate as given in Annexure - I. The nativity certificate should have the mandatory statement that “the Applicant is a native of the state of Tamil Nadu by birth”.**
- iv. **Overseas Citizen of India (OCI) / Persons of Indian Origin (PIO):** Candidates of OCI / PIO cardholders and Native of Tamil Nadu shall be permitted in TANUVAS counselling under the Open Category (OC). This will not apply to the candidates of OCI / PIO cardholders who are born in a foreign country after 04.03.2021 (*vide* GO.MS. No. 221, of Higher Education (J2) Department, Government of Tamil Nadu, dated 28.07.2023).

## 4.1.2 AGE LIMIT

### Minimum Age:

Candidates should have attained the age of **17 years as on 31<sup>st</sup> December, 2026.**

## 4.1.3 STREAM OF EDUCATION

### BVSc & AH

The candidates who studied in the Academic Stream (Physics, Chemistry and Biology or Botany and Zoology) and in the Vocational Stream (Biology and Agricultural Science (Agricultural Practices / Poultry / Dairying)) are eligible for applying to BVSc & AH degree programme.

### **BTech (Food Technology / Poultry Technology / Dairy Technology)**

For BTech degree programme, only candidates who studied in the Academic Stream (Mathematics, Physics, Chemistry and Biology) are eligible.

### **Vocational Stream Candidates for Tamil Nadu State**

**FIVE PER CENT (5%) OF THE TOTAL NUMBER OF SEATS** in BVSc & AH is reserved for the candidates studied under Vocational Stream of HSC of Tamil Nadu State (candidates studied in Vocational Stream of Board Examination other than Tamil Nadu are not eligible to apply). **The candidates from Vocational Stream shall be considered for admission to BVSc & AH degree programme only (not eligible for**

**BTech degree programme)** against the seats reserved for them and they will not be considered under any other categories.

#### 4.1.4 QUALIFYING EXAMINATIONS AND MINIMUM MARKS

- i. A pass in the Higher Secondary Course (10+2) / CBSE / any other examination recognized as equivalent thereto and fulfilling the below mentioned requirements are mandatory.
- ii. In addition, for those candidates who have appeared HSC Examination of Tamil Nadu State Board from March 2019, a pass in **11<sup>th</sup> standard examination is mandatory** (G.O. Ms. No. 195, School Education Dept., dated 14.09.2018 of the Government of Tamil Nadu).
- iii. The candidates who have passed 10+2 from **open school or as private candidates shall not be eligible**. Further, the study of biology as an additional subject at 10+2 level also shall not be permissible.
- iv. Only academic qualification examination marks secured by the candidate will be considered for the aggregate mark calculation. **Grace marks for co-curricular / extra-curricular activities will not be considered.**

### **4.1.5 NUMBER OF ATTEMPTS**

The maximum number of attempts made for passing the qualifying examination is limited to **THREE** for SC/ SCA / ST candidates and **TWO** for other candidates.

**THE IMPROVEMENT MARKS IN HSC OR EQUIVALENT EXAMINATION OF ANY YEAR INCLUDING OTHER STATE CANDIDATE WILL NOT BE CONSIDERED**

(GO. MS. No. 184 HE(J2) Dept. dated 9.6.2005 and GO. (St) No. 143 HE (J2) Dept. dated 6.5.2008).

### **4.2 COMMUNAL RESERVATION**

Selection shall be made for different community categories, following the rules of reservation of the Government of Tamil Nadu. The percentages of reservation available for different community categories are as follows:

### Government Orders for communal Reservation

- Tamil Nadu Ordinance No. 4 of 2007 published in the Tamil Nadu Government Gazette Extraordinary No. 262 dt. 15.09.2007 provides for reservation in respect of annual permitted strength in each branch or faculty for admission into educational institutions in the State including private educational institutions.
- For the Backward Class Muslims, it shall be three and a half percent within the thirty percent reservation for Backward Class as provided in the 1994 Act and in 2006 Act.
- G.O. Ms. No. 50, Adi Dravidar and Tribal Welfare (TD-2) 29.04.2009. (16% seat offered to Arunthathiyars within the seats reserved for scheduled castes for admission in Educational Institutions).

The list of communities eligible to compete against the reserved quota is furnished in **Appendix - I (List of Communities)**.

- ❖ **Candidates who are native of Tamil Nadu alone** will be considered for communal reservation. The caste recorded in the candidate's community certificate should appear in the list of castes / communities approved by the Government of Tamil Nadu.

- ❖ The applicants from Tamil Nadu State should have obtained a permanent community certificate in permanent card format / electronic form / digitally signed e-certificate only from the authorities given above on or before the last date prescribed for submission of online application. Community certificates obtained after the last date prescribed for submission of online applications will not be considered.
- ❖ Community certificates obtained from other states will not be considered for communal reservation, but will be considered as open category (OC) only if he / she fulfills the eligibility norms otherwise.
- ❖ For communities linked with Districts, the candidates should obtain their community certificate in the respective district except the communities mentioned in G.O. (Ms) No. 95 BC, MBC & Minorities Welfare Department dated 28.10.2009. Such of those community certificates obtained on or after 28.10.2009 will be considered. Community certificate obtained from other than the respective district will not be considered.
- ❖ Candidates who have not produced the Community Certificate in the form of Permanent Community Certificate [Card] or electronic form / digitally signed e-certificate at the time of verification of original certificates, their application will be treated under “Open Competition (OC)”. The candidate is further informed that in the event of such a decision, the eligibility conditions and norms prescribed for OC will be applicable for such candidates and if such candidates do not satisfy the norms of OC, their applications are liable to be rejected. No correspondence in this connection will be entertained.
- ❖ If a candidate submits a false / fabricated Community Certificate or Nativity Certificate or any other Certificate and found at a later point during the course of the study, it will result in expulsion of the candidate from the course and also legal proceedings / criminal action will be initiated against the candidate and their parents as per the provisions of law.

### **4.3 SPECIAL CATEGORIES**

Seats are reserved for special categories such as Differently abled, Sports Persons and Children of Ex-servicemen. The seats earmarked for the special categories will be allotted following the horizontal reservation. The seats will be allotted as per the rank in the concerned special category and accordingly, those seats will be deducted in

concerned community. If adequate number of eligible candidates is not available under special category, then the earmarked unfilled special category seats will be reverted back to the General category.

#### 4.3.1 Differently - abled

Five per cent (5%) of the total number of seats is reserved for the Differently - abled candidates / Persons with Benchmark Disabilities as per The Gazette of India - Extraordinary: Part III-Section 4. No.286 published on 08.07.2016, Ministry of Agriculture and Farmers welfare (Department of Animal Husbandry, Dairying and Fisheries).

**THE RESERVATION UNDER SPECIFIED DISABILITY IS PROVIDED RANGING FROM 40% TO 80%** as per Lr. No. 11404/AH6/2017-2 Dated: 16.10.2017 of the AHD&F (AH6) Dept., Govt. of Tamil Nadu and G.O (D) No.947, Health and Family Welfare Dept., dated 06.06.2019 and Right of Persons with Disability Act, 2016. The guidelines regarding the eligibility of candidates under Differently abled quota is given in **Appendix III**.

**Candidates with less than 40% disabilities are NOT ELIGIBLE** for reservation, provided that the candidates are eligible to apply for Undergraduate Degree Programmes of TANUVAS under general category. However, such candidates have to **submit a physical fitness certificate by the competent authority**. The presence of significant Locomotor Disability with or without any other significant disability – such as visual or hearing–speech or learning *etc.* which will make it difficult for the candidate to pursue and complete the course satisfactorily and may significantly increase the risk to the candidate – may be declared **INELIGIBLE** for admission. Other conditions for admission to the degree programmes are applicable as in the case of General Category.

The candidate appearing under differently-abled category will be physically examined by the medical officer / board specifically constituted for the purpose and **whose decision on eligibility is final**. The candidates who have previously applied for UG degree programmes under the differently abled category and made ineligible by the Medical Board are not eligible to apply for the subsequent years under this category. Such applications will be summarily rejected. The selected differently abled candidates of Tamil Nadu will be exempted from paying tuition fees, special fees and examination fees of the total college fees prescribed by the University as per GO MS. No. 113 dated 28.06.2024 of Government of Tamil Nadu.

[Reference: RC. No.2545514/SS-2/2026, Dt 29.04.2026 of District Revenue Officer / General Manager (Admin), SDAT, Chennai-3]. The eligible candidates should upload copy(ies) of the certificate(s) for having taken part in Sports Meet / Tournaments / Competitions and secured I, II or III place and / or participated in individual events / team games at the International / National / State / Regional / District level along with the details of Sports Certificates.**

The candidates from Academic Stream of the qualifying examination who wish to apply for BVSc & AH / BTech (Food Technology / Poultry Technology / Dairy Technology) degree program under Children of Ex-Servicemen Quota should produce a certificate in the format of **Annexure- II** from the Assistant Director of Ex-Servicemen Welfare Board of the District concerned that his / her father is an Ex-Serviceman and has served in the Armed Forces.

### 4.3.4 Government School Students (7.5% seats on preferential basis)

#### Seats reserved under

- i. BVSc & AH – 7.5 % of total seats of Tamil Nadu Quota
- ii. BTech (Food Technology / Poultry Technology / Dairy Technology) - 7.5 % of total seats of Tamil Nadu Quota

The "Tamil Nadu admission to Undergraduate Professional Courses on Preferential basis to students of Government Schools Act, 2021" (Act No. 14 of 2021) provides 7.5% seats on preferential basis (Horizontal reservation in each category of vertical reservation followed in the state of Tamil Nadu without affecting the existing 69% of rule of reservation in force) to the students who have studied from 6<sup>th</sup> to 12<sup>th</sup> standard in the State Government schools, in admission. The candidates from Academic Stream of the qualifying examination who wish to apply for BVSc & AH / BTech (Food Technology / Poultry Technology / Dairy Technology) degree programme under Government schools' student category should correctly mention the **unique EMIS number (Educational Management Information System) as issued by the Government of Tamil Nadu (School Education Department)** in Online application, which will be verified. Seats include all the seats in BVSc & AH and BTech courses excluding the seats reserved for all India quota;

- a. "Government schools" mean and include **Government schools, Corporation schools, Municipal schools, Panchayat Union schools, Adi Dravidar and Tribal Welfare schools, Kallar Reclamation schools, Forest Department schools and other schools managed by Government departments.**
- b. Student studied in Government schools shall also be entitled to compete for the Government seat, other than those set apart on preferential basis, along with the students who studied in private school.
- c. Admission of Students studied in Government schools on preferential basis shall be made by following the reservation as per the law in force.
- d. Notwithstanding anything contained in above, where adequate numbers of students studied in Government schools are not available for admission to the seats set apart on preferential basis, such unfilled seats shall be filled up with the students who studied in private schools".

*The seat allotment will be followed as mentioned in the GO (Ms) No. 167, Higher Education (J2) Department, dated 31.08.2021.*

- ii. Candidates should fill, upload necessary documents / certificates and submit the application through online at <https://adm.tanuvvas.ac.in> **on or before 17.06.2026, 5.00 PM.**
- iii. Candidates can apply for BVSc & AH and / or BTech (Food Technology) and / or BTech (Poultry Technology) and / or BTech (Dairy Technology) by selecting the appropriate options.
- iv. The candidates are requested to give their order of campus preference for the applied degree programmes, **which will be considered for Online counselling.**
- v. The candidates are requested to opt their preference of campus (Constituent / Affiliated) carefully before submission.
- vi. **After submission of application, the order of campus preference cannot be changed.**
- vii. There is **NO NEED TO SEND THE HARD COPY OF APPLICATION TO THE UNIVERSITY**. However, the candidates may take a print out of the application for future reference.
- viii. A **Specimen copy of Online application** form is available on the website for the candidates to understand this procedure and practice before online submission of their application.
- ix. **While filling-up of application form, the candidate has to make online payment of prescribed application fee using Credit cards / Debit cards / Internet Banking / IMPS / UPI.**

### 4.5.1 Normalization of Marks

As per Tamil Nadu Act No. 3 of 2007 dated 05.03.2007, the marks obtained by the students in the relevant subjects in the qualifying examination conducted by various Boards or Authorities shall be equated with the marks obtained by them in the same subjects in the qualifying examination conducted by the State Board of Tamil Nadu by adopting the method of normalization.

For example, if the highest mark secured by a student of the State Board of Tamil Nadu in Physics is 100% and the highest mark secured by a student of a Board other than Tamil Nadu State Board in the same subject is 90%, both the highest marks will be considered to be equal to 100%. If a student of the other Board secures 60 marks in Physics when the first mark in Physics in the same Board is 90, then the 60 marks of the Board will be considered to be equal to 66.67 marks of the Tamil Nadu State Board, as computed below:

$$\frac{60}{90} \times 100 = 66.67\%$$

After the normalization of marks in the relevant subjects in the qualifying examination conducted by the other Board, the qualified students of different Boards shall be ranked in a common merit list. The common merit list will be prepared for the total marks of 200.

### 4.5.2 Inter-se Merit

In cases, where more than one candidate has got the same mark in the common merit list, the *inter-se* merit among such candidates shall be determined as per G.O. Ms. No.73, Animal Husbandry, Dairying and Fisheries (AH6) Department, dated 24-05-2007 for the following degree programmes in the order of priority, as specified below:

### 4.6 RANKLIST AND COUNSELLING

The rank list for admission to BVSc & AH and BTech degree programmes will be published in the University Website - <https://adm.tanuv.ac.in>

#### 4.6.1 In-person verification

- i. The candidates who have applied under Differently abled have to appear **IN PERSON** along with the relevant documents at the venue specified by the University for physical examination by the medical board for making decision on eligibility.

- ii. The candidates who have applied under Sports quota have to appear **IN PERSON** along with the relevant original certificates and documents at the venue specified by the University for certificate verification (if required).

#### 4.6.2 Online counselling

- i. Online Counselling will be conducted on the basis of order of merit, rules of reservation of Government of Tamil Nadu and preference opted by the candidate.
- ii. **All the eligible candidates need to register (one-time registration) for participation in online counselling by payment of one-time counselling fee as prescribed by the University.**
- iii. The candidates who failed to register for online counselling **WILL NOT BE CONSIDERED FOR ADMISSION THEREAFTER.**
- iv. The selected candidates shall download their allotment letter. They have to report to the allotted campus within the prescribed time to submit their certificates / documents for verification and pay the prescribed fee. Upon submission of necessary documents and payment of prescribed fee, the candidate will be admitted to the respective degree programme and admission slip will be issued to the candidate and they shall report to the admitted colleges on the prescribed date of registration / orientation.
- v. Based on the vacancy position, sliding procedure (internal counselling) for campus change will be carried out only for already admitted candidates who have opted for sliding at the time of admission and fee payment. The sliding procedure will be carried out for five rounds of counselling only. **CANDIDATES WHO HAVE NOT OPTED FOR SLIDING WILL NOT BE CONSIDERED FOR FURTHER COUNSELLING.**
- vi. The resultant vacancies after sliding will be allotted to the candidates who have already registered for the counselling.
- vii. **MERE REGISTRATION FOR THE ONLINE COUNSELLING DOES NOT ENSURE SELECTION / ADMISSION OR ANY OTHER RIGHTS TO THE CANDIDATES SO REGISTERED.**
- viii. The candidates are requested to keep checking the University admission website regularly for the counselling particulars and updates.

### 4.6.3 Counselling fee

Candidates participating in counselling need to pay **one-time non-refundable Counselling fee** of Rs. 100/- for SC / SCA / ST candidates and Rs. 200/- for Others. **MERE PAYMENT OF COUNSELLING FEE DOES NOT ENSURE SELECTION / ADMISSION.**

### 4.7.1 Fee Exemption for Students Admitted Under 7.5% Government School Quota

As per the GO 221 Higher Education (J2) dated 15.11.2021, the State government will absorb the expenses for education in professional courses of students admitted under the 7.5% reservation for government school students (as specified by the state Government). The fees for counseling, tuition and hostel, would be paid by the Government itself. **They have to submit the proof for details of Government Schools in which studied from 6<sup>th</sup> Standard to 12<sup>th</sup> standard in Tamil Nadu.**

### 4.7.2 First Graduate Tuition Fee Concession

In the G.O.(Ms) No.85 Higher Education(J2) Department dated 16.04.2010, the Government has ordered to grant tuition fee concession to the candidates, who are to be the first graduate in a family. If the applicant's brother or sister has already availed First Graduate Tuition Fee Concession for studying Professional Courses, then the applicant is not eligible for such concession.

### NRI status of applicant / parents / sponsorer (as applicable)

(Ref.: OI-11011/01/2017-OIA-II dated 19.05.2017 of the Director, OIA-II division, Ministry of External Affairs, Government of India, Chanakyapuri, New Delhi)

- i. **Non-Resident Indian (NRI) is an Indian citizen staying outside India for more than 182 days in a year (proof for continuous stay to be produced).**
- ii. Candidates applying under NRI / wards of NRI / NRI-Sponsored category should submit recent **NRI Status Certificate of the Candidate / Parents / Sponsorer issued by the Indian Embassy of the Country** concerned with their seal as per **Specimen - I or I (a)** as applicable.
- iii. **An Overseas Citizen of India (OCI) Cardholder / Person of Indian Origin (PIO) have been granted parity with the NRIs. Necessary proof should be submitted along with the application.**
- iv. **Overseas Citizen of India (OCI) Cardholder will not be considered under Foreign National category for educational purposes** vide Ref. OI-11011/01/2017-OIA-II dated 19.05.2017 of the Director, OIA-II division, Ministry of External Affairs, Government of India, Chanakyapuri, New Delhi.
- v. **Overseas Citizen of India (OCI) Cardholder / Person of Indian Origin (PIO) who are having foreign passports / Indian passports will be considered as NRI only in the field of Education.**
- vi. **NRI and wards of NRI must submit a certificate from competent authority in Specimen I. NRI who is financially supporting the candidate must be a blood**

**relative such as father / mother / own brother / own sister / uncle (Own brother of father or mother) / aunt (Own sister of father or mother) only. The Relationship certificate from competent authority needs to be produced as shown in specimen I (a) and II.**

Further, the candidates have to fulfill the other conditions *viz.*,

- a. **NRI or OCI candidate / NRI or OCI parents / NRI or OCI sponsorer should have an active NRI / NRE / Foreign bank account. They have to submit their bank statement (NRI / NRE / Foreign bank account) for at least SIX months, preceding the date of submission of application.**

## 5.1 ELIGIBILITY

- ii. Candidates must have completed 12 years (10+2) of school education of Indian System, i.e. HSC / CBSE / ISC or its equivalent.
- iii. Candidates must have studied in **English Medium** and obtained a pass with good marks / grades.
- iv. For BVSc & AH, the candidate should have studied Biology (or Zoology and Botany), Physics and Chemistry in 11<sup>th</sup> and 12<sup>th</sup> standard.
- v. For BTech, the candidate should have studied Biology, Mathematics, Chemistry and Physics in 11<sup>th</sup> and 12<sup>th</sup> standard.
- vi. Admission under Non-Resident Indians (NRIs) will be made on the basis of the merit in the qualifying (Higher Secondary / Equivalent) examination and entrance examination conducted by the University.

### 5.1.1 Age limit

#### *Minimum Age:*

Candidates should have attained the age of **17 years as on 31<sup>st</sup> December, 2026.**

#### *Maximum Age:*

Candidates applying for the degree programmes should not have completed **21 years of age as on 01-07-2026.**

**NO RELAXATION OF MINIMUM AND MAXIMUM AGE LIMIT IS PERMISSIBLE ON ANY GROUNDS.**

Candidates who are eligible for **NRIs / Wards of NRIs / NRI Sponsored category** should fill, upload necessary documents / certificates and submit applications online at <https://adm.tanuvvas.ac.in> on or before **17.07.2026, 5.00 PM IST.** Candidates can apply for BVSc & AH or BTech (Food Technology) or both by selecting the appropriate options.

Online application form and guidelines for admission under NRI category are available in the University website: <https://adm.tanuvvas.ac.in> **from 25.05.2026, 10.00 AM IST to 17.07.2026, 5.00 PM IST.** There is **NO NEED TO SEND THE HARD COPY OF APPLICATION TO THE UNIVERSITY.** However, the candidates may take the print out of the application and keep with them for their reference.

**While filling up of online application form, the candidate has to make online payment of application fee of US \$ 30 (Thirty US Dollars only) through Credit cards / Debit cards / Internet Banking.**

### 5.2 SELECTION

### 6.1 ELIGIBILITY

#### BVSc & AH

*(G.O.(Ms.) No. 50 of Animal Husbandry, Dairying and Fisheries (AH-6) Department dated 27-05-2009)*

Applicants must be **FOREIGN NATIONALS** possessing **VALID FOREIGN PASSPORT** who are **NOT OF INDIAN ORIGIN**. Overseas Citizen of India (OCI) Cardholder / Person of Indian Origin (PIO) even having a foreign passport **WILL NOT BE CONSIDERED** as a foreign national. Candidates must have completed 12 years (10+2) of school education of Indian System or its equivalent. Candidates must have studied in **English Medium** and obtained a pass with good marks / grades as per their systems of education in Biology (or Zoology and Botany), Physics and Chemistry. Candidates who studied in other medium of instruction should produce a proficiency certificate from recognized Institutes for their skills in English (reading, writing and speaking).

#### BTech (Food Technology)

*(G.O.(Ms.) No. 1 of Animal Husbandry, Dairying and Fisheries (AH-6) Department dated 02-01-2015)*

Applicants must be **FOREIGN NATIONALS** possessing **VALID FOREIGN PASSPORT** who are **NOT OF INDIAN ORIGIN**. Overseas Citizen of India (OCI) Cardholder / Person of Indian Origin (PIO) even having foreign passport **WILL NOT BE CONSIDERED AS FOREIGN NATIONAL**. Candidates must have completed 12 years (10+2) of school education of Indian System or its equivalent. Candidates must have studied in **English Medium** and obtained a pass with good marks / grades as per their systems of education in Biology, Mathematics, Physics and Chemistry. Candidates who studied in other medium of instruction should produce a proficiency certificate from recognized Institutes for their skills in English (reading, writing and speaking).

### 6.1.1 Age limit

#### **Minimum Age:**

Candidates should have attained the age of **17 years as on 31<sup>st</sup> December, 2026.**

#### **Maximum Age:**

Candidates applying for the degree programmes should not have completed **25 years of age as on 01-07-2026.**

**NO RELAXATION OF MINIMUM AND MAXIMUM AGE LIMIT IS PERMISSIBLE ON ANY GROUNDS**

### 6.2 OTHER ELIGIBILITY CONDITIONS

Further, the candidates have to fulfill the other conditions *viz.*,

- i. **Candidates who have been selected under Foreign National category should maintain the status of Foreign National category under which they are selected till the completion of their course.**
- ii. **Foreign National candidate / parents should have active Foreign National bank account. They have to submit their bank statement for at least SIX months, preceding the date of submission of application.**
- iii. **The prescribed Institutional Economic Fee and Development fee should be paid in US dollars only from the active foreign bank account of the Foreign National candidate / parents. Payment of fee in any other currency and through any other account is NOT ENTERTAINED.**

Candidates who are eligible **under Foreign National category** should fill, upload relevant documents / certificates and submit applications online at <https://adm.tanuvvas.ac.in> on or before **17.07.2026, 5.00 PM IST**. Candidates can apply for BVSc & AH or BTech (Food Technology) or both by selecting the appropriate options.

Online application form and guidelines for admission under **Foreign National category** are available on the University website: <https://adm.tanuvvas.ac.in> from **25.05.2026, 10.00 AM to 17.07.2026, 5.00 PM**. There is **NO NEED TO SEND THE HARD COPY OF APPLICATIONS TO THE UNIVERSITY**. However, the candidates may take the print out of the application for their future reference.

While filling-up of online application form, the candidate has to make **online payment of application fee of US \$ 100 (One hundred US Dollars only) through Credit cards / Debit cards / Internet Banking.**

**PAYMENT BY ANY OTHER MODE WILL NOT BE ACCEPTED**

### **6.2.1 Study in India (SII) portal**

**Students applying under the Foreign National category for BVSc & AH and BTech (Food Technology) courses in Tamil Nadu Veterinary and Animal Sciences University, Chennai – 51 should also apply through the Study in India portal.**

Study in India (SII) portal “<https://studyinindia.gov.in/>” was launched by Ministry of Education (MoE), Ministry of Home Affairs (MHA) and Ministry of External Affairs (MEA) on 3<sup>rd</sup> August, 2023. It is a dedicated website for University admission and visa applications for foreign students who wish to pursue their higher education in Indian Higher Education Institutes (HEIs). With the launch of the portal, it is now mandatory for international students seeking admission in Indian HEIs to register on the SII portal for every full-time or short-term course. The portal provides a structured mechanism to facilitate foreign students to meet their visa obligations. A unique ID will be generated when a student register on the portal and this ID will have to be quoted with Visa applications.

## **6.3 SELECTION**

Selection will be done based on the Academic Merit of the eligible candidates. Eligibility will be decided based on scrutinization of subjects studied and marks obtained in the concerned subjects. The selection list will be hosted on the University website.

## **6.4 FEES**

### **6.4.1 Institutional Economic Fee and Development Fee**

On receipt of the allotment letter, candidates of Foreign National category have to pay the Institutional Economic Fee and Development Fee as prescribed by the University, through **wire transfer or internet banking.**

Note: For each extended year of study, an additional fee of US \$ 4,200 per annum needs to be paid.

### ii) Development fee

A development fee of **US \$ 2,800** should be paid at the time of admission (one-time payment).

#### 6.4.1.2 Other regular fees

Other regular fees such as Tuition fee, Special fee, Examination fee, Boarding and Lodging fees, etc. **should be paid either in Indian Rupees or its equivalent in US Dollars** at the time of admission or when required to be paid, as per the rules of the University. Fees including Institutional Economic Fee and Development Fee once paid are not refundable.

**Candidates shall refer detailed Guidelines for Admission under the Foreign National quota issued by the University for further information.**

**For BVSc & AH – Two seats over and above the admission strength at Madras Veterinary College, Chennai (G.O. (Ms.) No.141 of Animal Husbandry, Dairying and Fisheries (AH6) Department, Dated: 30-06-2015).**

### 7.1 SELECTION

Selection will be through All India Council for Technical Education (AICTE), Government of India under PM-USPY Scheme.

## 8. SYSTEM OF EDUCATION

### 8.1 BVSc & AH

#### **(4½ years of course work & One year of internship as per MSVE Regulations, 2016)**

The syllabus and regulations prescribed by the Veterinary Council of India (MSVE - 2016) is adopted for BVSc & AH degree programme. An enrolled student should complete the course credits prescribed from time to time and shall have to earn a minimum Overall Grade Point Average (OGPA) of **5.0 out of 10.0** in order to earn BVSc & AH degree. After completion of course credits at the end of 4½ years, the student should satisfactorily complete an Internship Training Programme of one year duration.

### 8.2 BTech (Food Technology/ Poultry Technology / Dairy Technology)

#### **Semester Course Credit System (8 Semesters)**

The pattern of instruction and evaluation is the semester course credit system under the syllabus and regulations prescribed by the ICAR / TANUVAS. An enrolled student should complete the course credits prescribed from time to time and shall have to earn a minimum Overall Grade Point Average (OGPA) of **5.0 out of 10.0** in order to earn BTech (Food Technology) / BTech (Poultry Technology) / BTech (Dairy Technology) degree. The student shall satisfy the minimum residential requirement of 8 semesters of study including the compulsory in-plant training for one semester.

## 9. SCHOLARSHIPS / LOANS

Scholarships such as SC / SCA / ST Welfare and Backward Class Scholarships, Scholarships given by Government of India, Government of Tamil Nadu and Indian Council of Agricultural Research, *Pattukottai Azhagiri* Endowment Scholarship, *Pudhumaipen* and *Thamizhputhalvan* Schemes and scholarships from other agencies and financial assistance from Tamil Nadu Agricultural Labourers - Farmers (Social Security and Welfare) Scheme are available for the deserving candidates admitted under Tamil Nadu State quota. The scholarship may vary according to the degree / college to which the candidates are admitted and respective funding agencies. The candidates should furnish copies of certificates (**Annexure – III (A) and III (B)**) to the effect that he / she is the first graduate in his / her family from the appropriate authority along with the application. If the information furnished by him / her is found incorrect at a later stage, he / she needs to repay the entire amount spent on him / her by the Government, besides legal action being initiated against him / her.

## 9.1 POST MATRIC SCHOLARSHIP

### **SC / SCA / ST students**

In the G.O. (Ms.) No. 6 Adi Dravidar and Tribal Welfare (AD3) Department dated 09.01.2012; G.O. (Ms.) No. 92 Adi Dravidar and Tribal Welfare (AD3) Department dated 11.09.2012; and G.O. (Ms.) No. 16 Adi Dravidar and Tribal Welfare (AD3) Department dated 24.02.2014, the Government has ordered to grant Post Matric Scholarship to SC / SCA / ST candidates and SC / SCA converted Christians, whose parental annual income is **less than Rs. 2,50,000/-** from all the sources shall only be eligible. The eligible candidates have to submit income certificate obtained from the competent authorities.

### **BC / MBC / Minorities students**

In the G.O. (Ms.) No. 68 BC, MBC & Minorities Welfare Department dated 18.11.2021, the Government has ordered to grant Post Matric Scholarship to BC / MBC / Minority candidates, whose parental annual income is **less than Rs. 2,50,000/-** from all the sources shall only be eligible. The eligible candidates have to submit income certificate obtained from the competent authorities.

## 9.2 FINANCIAL AID AND STUDENT LOANS (PM-VIDYALAXMI SCHEME)

The PM-Vidyalaxmi Scheme, a Government of India initiative offering collateral-free and guarantor-free education loan is available for all students who are getting admission in this Institution and who are desirous of availing education loans to pursue their higher education. The candidates can visit the portal <https://pmvidyalaxmi.co.in>. The portal does not charge any amount from the applicant. Through the portal, candidates can:

- Apply to multiple banks for education loan,
- Access collateral-free and guarantor-free education loans,

To address queries raised by the students, there is a dedicated Toll-free number 1800- 1031.

## 10. HOSTEL FACILITIES

- a) Hostel facilities for the students are available in each campus and the mess functions on a dividend system / contract basis.
- b) The students will be accommodated in the hostels to the extent possible, subject to availability.
- c) A sum of Rs.5,000/- will be collected as caution deposit for hostellers.
- d) In addition, the lodging fee of Rs. 1000/- will be collected annually by the concerned hostel authorities.

## 11. PREVENTION OF RAGGING

Ragging is punishable as per Proceedings of the Supreme Court of India in SLP (C) No.24295/2004 conveyed by the University Grants Commission, *vide* Letter No.F.1-8/2006 (Cpp-II) dated 04.03.2008. **If any incident of ragging comes to the notice of the authorities, the concerned student shall be directed to explain and if his / her explanation is not found satisfactory, the authority will expel him / her from the Institution.**

## 12. REGISTRATION AFTER ADMISSION

- (i) A candidate who has been selected for admission to BVSc & AH / BTech (Food Technology) / BTech (Poultry Technology) / BTech (Dairy Technology) degree programme and paid the fees to secure the seat shall register for the requisite courses **within seven working days** from the date of commencement of registration for the first year, failing which his / her admission will stand cancelled automatically. Registration can be done **without fine on the first two working days and with a fine of Rs.100/- on the remaining five working days.**
- (ii) A candidate who has paid the fees but fails to register on the date specified or fails to inform his / her intention of not registering for the course, **within one week** from the date specified for registration, is liable to forfeit the fees paid by him / her.
- (iii) **Agreement and Surety bond:** Candidates selected for admission and his / her parent / guardian will have to execute agreement and surety bonds [as mentioned in Annexure IV (A) and IV (B)] during admission to college. Failure to execute the Agreement and surety bonds will lead to cancellation of admission.
- (iv) **Physical fitness:** Candidates need to submit a physical fitness certificate (format prescribed by the university) from the Government Medical Officer not below the rank of Civil Surgeon at the time of registration. If the candidate is certified to be unfit to pursue the study by the Government Medical Officer, he / she will not be permitted to register on any ground.

### 13. MIGRATION AFTER CLOSURE OF ADMISSION

Apart from Internal counseling (sliding) during the admission process, **campus migration / transfer within the college campuses of TANUVAS and from any other Universities is NOT PERMISSIBLE under any grounds / circumstances.**

### 14. DISCONTINUANCE OF COURSE

#### 14.1 Before registration

A candidate, who intends to withdraw from the degree programme before registration, is entitled to get a refund of 80% of the tuition fee and 100% of all the other fees paid by him / her, provided the claim for refund is made **within one month** from the date notified for registration / commencement of classes. Otherwise, he / she is liable to forfeit the full fees paid for the admission.

#### 14.2 Before the closure of admission

A student who desires to leave the degree programme after registering for the course and before the date of closure of admission, irrespective of the fact that he / she has attended the classes or not, is entitled to get a refund of 30% of the tuition fee and 50% of all the other fees except laboratory fund.

#### 14.3 After the closure of admission

A student who desires to leave the degree programme after the closure admission (as decided by the University) or on any date of subsequent years, irrespective of the fact that he / she has attended the classes or not, should pay a discontinuance fee of **Rs.3,00,000/-** (Rupees Three lakhs only) for BVSc & AH course as per the bond executed as penalty.

### 15. INSTRUCTIONS TO FILL ONLINE APPLICATION

1. Candidates should carefully read the Prospectus before filling up the online application form.
2. Candidates should submit applications **online** at <https://adm.tanuvas.ac.in> **on or before 17.06.2026, 5.00 PM. APPLICATION SUBMITTED THROUGH ONLINE ALONE WILL BE ACCEPTED. OTHER FORMATS OF APPLICATION WILL SUMMARILY BE REJECTED.**
3. Candidates shall apply for BVSc & AH and / or BTech (Food Technology) and / or BTech (Poultry Technology) and / or BTech (Dairy Technology) degree programmes

through a single registration, provided they have paid the prescribed fees (for each degree programmes) as detailed below, before applying.

The scanned copies of certificates / documents to be uploaded for online application are HSC / CBSE / other equivalent mark sheet, 11<sup>th</sup> mark sheet (if applicable), copy of Transfer Certificate, copy of Community Certificate, relevant Certificates for Special categories (if required) and copy of Nativity Certificate (if required).
5. If, for any reason (for want of more details), the candidate is not able to fill in all the required columns at a stretch, he / she may **SAVE** the application for future access. Upon saving the application, the candidate can **Login by entering their e-mail / mobile number and password** for editing the contents later and submission before the due date.
6. After filling in all the relevant columns in the application and uploading necessary documents / certificates, the candidates may re-check the details provided by them before submission through **PREVIEW**.
7. **Candidates should ensure that the correct amount of ONLINE APPLICATION FEE is paid by using the method viz. a) Credit Card b) Debit Card c) Internet Banking d) IMPS and e) UPI through the ONLINE PAYMENT GATEWAY.**

**12. Sports quota:**

- a. The candidates of academic stream who wish to apply for BVSc & AH / BTech (Food Technology / Poultry Technology / Dairy Technology) degree programme under **sports quota** are requested to read the details and guidelines for sports quota (**Appendix – II**).
- b. They are requested to arrange the certificates year-wise (**June 2022 to May 2023, June 2023 to May 2024, June 2024 to May 2025 and June 2025 to May 2026** as mentioned in **Appendix - II**) and scanned copy of the sports certificates and related documents / forms should be kept ready before filling the application.
- c. The candidates need to fill the relevant details of sports particulars and upload the relevant certificates year-wise.
- d. After filling sports particulars and uploading the certificates, the candidates shall view the summary of the sports particulars. Candidates may edit the particulars for any changes, if required.
- e. Mere filling and uploading of the sports certificates **DOES NOT GUARANTEE** for assignment of marks as claimed by the candidate. The marks for sports category will be assigned by the competent authority after scrutinizing the certificates / documents uploaded by the candidates. **MARKS ASSIGNED BY THE COMPETENT AUTHORITY IS CONSIDERED AS FINAL FOR MERIT LIST AND SELECTION.**
- f. Candidates cannot add / modify any documents / certificates after final submission. Hence, candidates are requested to read the guidelines carefully, fill the particulars promptly, upload the certificates / documents correctly and verify before submission.

**13. In case of revaluation / re-totaling in respect of qualifying examination,** the copy of revaluation / re-totaling mark certificate should be sent to **“The Chairman,**

**Admission Committee (UG)”,** immediately by mentioning the application number already submitted.

14. Candidates **should ensure that correct particulars of date of birth, community, marks and nativity are furnished by him / her in the application.** On scrutiny, if any of these particulars furnished in the application are found incorrect:

- i. He / she will forfeit admission to the degree programme itself, no matter at what stage of the course he / she may be at that time.
- ii. He / she will be debarred from pursuing any degree programme of this University and other Universities of Tamil Nadu for three years.
- iii. Legal action will be initiated against him / her for furnishing the wrong information.
- iv. Admission is subject to verification of mark certificates by the Director of respective boards of examinations and if the mark certificate is found to be fake, admission is liable for cancellation besides criminal action being taken.

15. **Community Certificate** is subject to verification by the District Vigilance Committee of the district concerned and if the community of the candidate is found to be untrue, admission is liable for cancellation besides criminal action being taken.

#### **Important Note**

- ❖ The contents in the application form and prospectus are subject to modification or revision that may be issued from time to time by the University and Government of Tamil Nadu.

## **16. DISPUTE REDRESSAL**

With respect to the interpretation of the provisions of any matter not covered in this prospectus, the decision of the University shall be final and binding on all the parties concerned. Any complaints, grievances *etc.*, related to UG admissions and academic matters must be first referred to the Chairman, UG Admission Committee, Tamil Nadu Veterinary and Animal Sciences University, Chennai who will be the appellate authority with respect to such complaints / disputes. The Courts having their jurisdiction at Chennai alone can adjudicate on all matters and disputes related to admissions and academic matters. Further, any legal question arising out of the admission shall be entertained only when raised within 30 days from the declaration of the result. No disputes will be entertained after the closure of admission.

All the communication from the University about admission to the eligible candidates will be sent only to their registered mobile number (SMS) and email. The candidates are requested to check the TANUVAS website regularly for updates.

## GUIDELINES FOR SPORTS QUOTA

## SELECTION OF CANDIDATES UNDER QUOTA FOR EMINENT SPORTS PERSONS

1. The purpose of this quota is to recognize and give weightage to the sports eminence of the candidates and hence marks for sports achievements alone will be considered in ranking the candidates, provided the candidates have obtained the minimum academic marks specified. The candidates are expected to continue good performance in sports, even after admission.
2. The candidate shall submit **all the sports certificates** along with participation certificates and relevant forms issued by Associations / recognized Federation, but only one highest achievement in a tournament (among the International, National, State, Regional, and District) in an academic year will be considered for awarding marks. **Last four academic year sports achievements will be considered** for the award of marks (from 01.06.2022 to 31.05.2023, 01.06.2023 to 31.05.2024, 01.06.2024 to 31.05.2025 and 01.06.2025 to 31.05.2026). Candidates shall refer recognized association list.
3. Selection of the candidate will be based on the marks obtained by the candidate strictly following the guidelines given in the tables below:

- 1. Participation or achievement in international tournaments will be considered only with earlier achievements at National and State level tournaments. Direct participation / Selection trials / camps in any International or National tournaments will not be considered for award of marks.**
2. The highest achievement in only one annual regular tournament, officially conducted in a regular manner by the member National Olympic Committee (NOCs) authorized by the International Olympic Committee (IOC) / International Sports Federations affiliated to the IOC will be considered for award of marks. The players / sports persons representing the Country in such tournaments through Indian Olympic Association (IOA) or respective National Sports Federations recognized by the Ministry of Youth Affairs and Sports, Government of India or IOA will be considered for the award of marks in each year.
3. Only tournaments officially recognized by the Indian Olympic Association / respective Official National Sports Federations recognized by MYAS will be considered for the award of marks (for each year) from 01.06.2022 to 31.05.2023, 01.06.2023 to

31.05.2024, 01.06.2024 to 31.05.2025 and 01.06.2025 to 31.05.2026.

4. Certificates of Participation or Achievements in tournaments submitted along with Form I alone are eligible for marks indicated in Table (I) above (should be submitted before the last date for submission of application).
5. **Players who participated in any of the Categories I, II and III in Table (I) should produce the copies of the following:**
  - i. VISA, Immigration entry in the passport, clearance from Ministry of Youth Affairs and Sports (Government of India), Indian Olympic Association and respective National Sports Federations including BCCI.
  - ii. The fixture, draw, schedule of events, players' accreditation, National Medal, Merit, Diploma, Participation certificate and Form-I issued by respective National Sports Federation and certificates signed and issued in the prescribed format by the President or Secretary General of the National Olympic Committee of the Organizing Country and International Sports Federation.

#### **4 (b) For National Tournaments**

1. The National tournaments should have been officially be recognized as the regular annual championships / tournament by MYAS or IOA or SAI or SDAT or SGFI Nationals conducted every year by school education department in age groups (U-14, U-17, U-19) or respective Official National Sports Federation will be considered (for each year) for the award of marks.
2. Marks will not be awarded for selection trials and coaching camps.
3. Tournaments conducted by the Federation which are not recognized by the IOA or MYAS, TNOA or SDAT at National Level for a particular period will not be considered for award of marks. (Refer recognized association list).
4. Candidates must have participated at Zonal / Cluster, District, Regional / State, National and International in a particular Game / Sport in the same hierarchical order as per the existing norms applicable for a particular Game / Sports.

#### **4 (c) For State Tournaments**

1. The State Level Tournaments should officially be recognized as the regular annual championships or tournaments, by the respective Official State Association or SAI or SDAT or School Education Department of Tamil Nadu will be considered (for each year) for the award of marks.
2. Marks will not be awarded for selection trials and coaching camps.

3. Any tournaments conducted by the Association which are de-recognized by the SDAT at the State Level for a particular period will not be considered for award of marks (Refer recognized association list attached in annexure).

#### **4 (d) For Tamil Nadu Board / CBSE / KV Schools / ICSE / ISC - Sports Achievements**

1. Tamil Nadu Board Schools, KVS, ISCE / ISC and CBSE schools, School Zonal and School Cluster level achievements will not be considered.
2. The candidates participated in the tournaments conducted by CBSE, KVS, ISCE / ISC and KV schools, at Regional / South zone are equated to Regional level achievements, and the National level achievements are equated to State level of State / Matric Board Schools.

#### **5. GENERAL CONDITIONS**

1. For consideration of candidates seeking admission under the category of eminent sports person, he/she should attach all the attested photocopies of participation certificates and the relevant forms issued by the competent sports authorities, along with the application. **All original sports certificates and relevant forms/documents must be submitted during the certificate verification.**
2. Participation / achievements in each academic year from 01.06.2022 to 31.05.2023, 01.06.2023 to 31.05.2024, 01.06.2024 to 31.05.2025 and 01.06.2025 to 31.05.2026 in sports / games shown in the list alone will be considered for the award of marks. National or State Level Championships or Tournaments conducted by Sports Federations or Associations recognized by MYAS or IOA or SDAT or TNOA alone will be considered for award of marks (Recognition of State Associations / National Federations should be relevant to the year concerned).
3. The relevant attested copies of certificates issued by the competent authorities as detailed below (Table VI) are to be submitted along with the application before the last date for submission of the applications.

4. Invitational or Memorial or any indifferent nomenclature or title of tournaments or Private Non-affiliated or Championships at District or State or National or International level will not be considered for marks.
5. District or Inter–district Championship means the championship conducted by the respective recognized District or State Sports Association for the State of Tamil Nadu.
6. Direct participation or achievement at any level without participating in the qualifying level competitions such as District or State or National or direct selection conducted by District or State Sports Association or National Sports Federation to represent the District or State or National or International tournaments or championships will not be considered for award of marks.
7. For international achievements in Tennis, marks for Gold, Silver and Bronze will be awarded to players who ranked first, second and third respectively in the ATP or WTA rankings of International Tennis Federation. For awarding participation marks for the top 5 ranked players will be considered from the ATP or WTA list published by the International Tennis Federation. Necessary document and proof should be enclosed by the candidate.

For National or State level achievement in Tennis, marks for Gold, Silver and Bronze will be awarded to players who ranked first, second and third respectively in the AITA or TNTA at National or State. For awarding participation marks for the top 5 ranked players will be considered from the list published by AITA or TNTA at National or State level based on the ranking. Necessary document and proof should be enclosed by the candidate.

8. **Certificates should be in printed form and necessary Form – I and II should be in the prescribed format (Certificates or forms issued in letter pads will be invalid).**
9. All other sport disciplines in which ranking is the criteria for assessment of achievement, rules indicated in item 7 above will be applicable for award of marks.
10. For Cricket, the annual official Championships or Tournaments conducted within the country under the auspices of TNCA or BCCI at District or State or National Level alone will be taken into consideration for that year.

11. Multiple events in a particular sport must be standardized events and in accordance with the events organized by the approved international Federations. Events newly created and not in accordance with the requirement will not be considered for award of marks.
12. **The participation or achievements of candidates with nativity of Tamil Nadu who represented Tamil Nadu alone are eligible for marks under National Category.**
13. **Tamil Nadu Native students studying in abroad shall be eligible for award of marks, provided their sports certificates indicate representation of a district in Tamil Nadu at the district level, representation of Tamil Nadu at the national level and representation of India at the International level.**
14. **Only Tamil Nadu candidates are eligible to apply for admission under Sports Quota and only the KVS, CBSE and ICSE / ISC schools within Tamil Nadu are eligible for marks.**
15. **Tamil Nadu native students studying in Other State will be eligible for awarding marks, provided their Sports Certificates reflect representation of a district in Tamil Nadu at the district level, representation of Tamil Nadu at the national level and representation of India at the International level.**
16. A Committee constituted by the University for this purpose will rank the candidates based on the marks assigned to the certificates enclosed along with the application. Candidates with a minimum sports mark of 5 and above alone will be considered for ranking.
17. **All the achievement certificates are to be supported necessarily by the relevant participation certificates and appropriate forms. No further enclosures or certificates will be entertained after the last date for submission of completed application.**
18. Highest achievement or participation certificates obtained by candidates at different levels such as District or State or National or International in each year along with earlier achievements should be enclosed without fail (A candidate shall enclose a copy of all eligible certificates for scrutiny).
19. Candidates in proportion to the available seats will be called for verification of the Originals / relevant documents (if required)
20. If any candidate fails to produce the requisite Original Certificates or Forms, his/her place will be allotted to the candidate next in rank and so on. The consequential

vacancy at the end of the rank list will be filled up from among the additional candidates according to their ranks.

21. All the highest level of participation or achievement should be supported by earlier achievements at all levels of competition.
22. Allotment of earmarked Sports Quota seats will be made to the candidates based on their rank before the start of main / general Counselling.
23. Candidates securing admissions under Eminent Sports Persons quota should sign an undertaking at the time of receiving allotment order, assuring participation in sports activities in the college preferred by them.
24. Legal action would be taken on parents and candidates for furnishing bogus documents. They should ensure that the certificates obtained are from competent authorities.
25. A CANDIDATE CAN UTILIZE THE SPORTS QUOTA ONLY ONCE.
26. Candidates applying for Sports Quota Category should verify and ensure the marks in **Appendix II**, before submitting the online application. Further, the marks are subject to change by the scrutiny committee based on the eligibility norms.

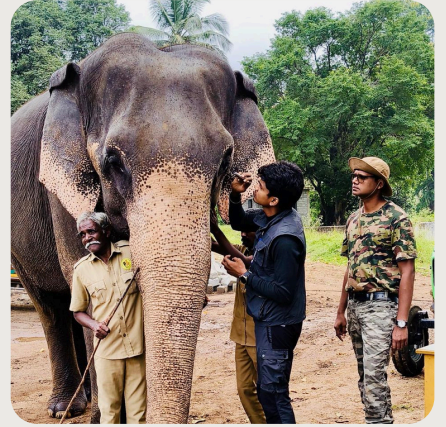
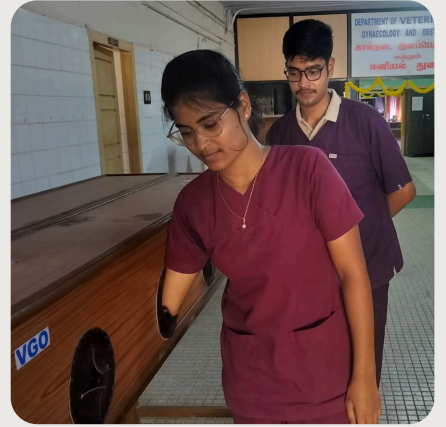

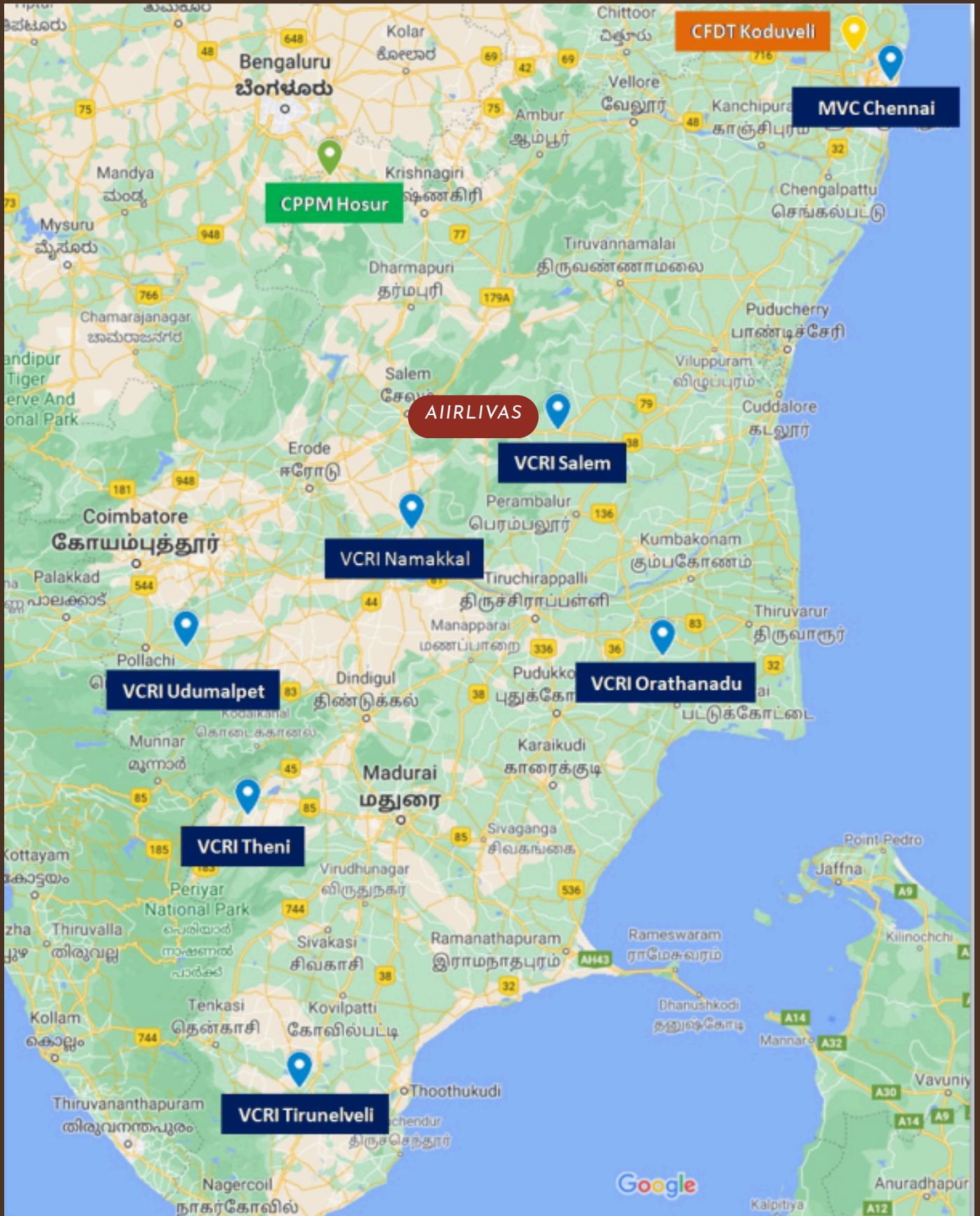
