1. ADMISSION REQUIREMENTS

1.1. Application Form

The candidate should fill, upload necessary documents / certificates and submit applications online at https://adm.tanuvas.ac.in from 26.05.2025, 10:00 AM IST to 27.06.2025, 5.00 PM IST. There is NO NEED TO SEND THE HARD COPY OF APPLICATIONS TO THE UNIVERSITY. However, the candidates may take the printout of the application for their reference.

Only online application will be accepted, other formats will summarily be rejected.

1.1.1 Study in India (SII) portal:

Students after applying under Foreign National category for BVSc & AH and BTech (Food Technology) courses in Tamil Nadu Veterinary and Animal Sciences University, Chennai –51, should also apply through the Study in India portal from the academic year 2025-26.

Study in India (SII) portal https://studyinindia.gov.in/ was launched by the Ministry of Education (MOE), Ministry of Home Affairs (MHA) and Ministry of External Affairs (MEA) on 3rdAugust, 2023. It is a dedicated website for university admission and visa applications for foreign students who wish to pursue their higher education in Indian Higher Education Institutions (HEIs).

With the launch of the portal, it is now mandatory for international students seeking admission in Indian HEIs to register on the SII portal for the academic session 2025-26 onwards for every full time or short-term course. The portal provides a structured mechanism to facilitate foreign student to meet the visa obligations. A unique ID will be generated when a student register on the portal and this ID will have to be quoted in the Visa applications.

1.2. Eligibility

- > APPLICANT MUST BE A FOREIGN NATIONAL POSSESSING FOREIGN PASSPORT AND MUST NOT BE OF INDIAN ORIGIN.
- Overseas Citizen of India (OCI) Cardholder / Person of Indian Origin (PIO) even having Foreign passport WILL NOT BE CONSIDERED AS FOREIGN NATIONAL.

1.3 Academic Qualifications

i) Eligibility for admission to BVSc & AH

Candidates must have completed **12 years (10+2) of school education of Indian system or its** equivalent for BVSc & AH programme.

Candidates who have studied in **English medium** and obtained a pass in the qualifying examination with Good Grades in **Biology (or Botany and Zoology), Physics and Chemistry** are eligible for admission to the above programmes.

Candidates studied in other medium of instruction **should produce the proficiency certificate for their skill in English (reading, writing and speaking)** from recognized Institutes.

ii) Eligibility for admission to BTech (Food Technology)

Candidates must have completed 12 years (**10+2**) of school education of Indian system or its equivalent for BTech (Food Technology) programme.

Candidates who have studied in **English medium and** obtained a pass in the qualifying examination with Good Grades in **Biology**, **Mathematics**, **Physics and Chemistry** are eligible for admission to the above programmes.

Candidates studied in other medium of instruction **should produce the proficiency certificate for their skill in English (reading, writing and speaking)** from recognized Institutes.

1.4 Age limit:

Minimum

Candidates should have attained the age of **17 years as on 31st December, 2025.**

Maximum

Candidates should not have completed 25 years as on 01.07.2025.

NO RELAXATION OF MINIMUM AND MAXIMUM AGE LIMIT IS PERMISSIBLE ON ANY GROUNDS

1.5. Application Fee

During filling of online application form, the candidate has to make online payment of application fee of US \$ 100 (One hundred US Dollars only) for each course through Credit cards / Debit cards / Internet Banking / IMPS / UPI.

PAYMENT BY ANY OTHER MODE WILL NOT BE ACCEPTED

1.6. Last date for submission of online application

The last date for submission of online applications and uploading of the necessary enclosures is on or before 27.06.2025, 5.00 PM IST. The cut-off date for eligibility of qualification is the last date of the application. All the necessary certificates / documents enclosures must be uploaded through online mode only. Further, the candidate should submit Eligibility Certificate / No Objection Certificate from embassy of the respective country / government.

If any of the required certificates is not enclosed, the application will be summarily rejected.

1.7. Selection of candidates

Selection will be done based on Academic Merit of the eligible candidates. Eligibility will be decided based on scrutinization of subjects studied and marks obtained in the concerned subjects.

Candidates who have been selected under Foreign National category should maintain the status of Foreign National category under which they are selected till the completion of their course.

1.8. Original Documents to be submitted at the time of admission

- 1. Proof for the Citizenship of the candidate
- 2. Photocopy of the passport of the candidate (original Passport to be shown for verification)
- 3. Qualifying mark list of the candidate: if the grades are produced, Certificates showing equivalent marks to grades obtained from competent authority should be submitted.
- 4. Certificate showing that the candidate has undergone the qualifying school education in **English medium** (or) Certificate showing the skill of English (reading, writing and speaking) from recognized Institutes.
- 5. Copy of Valid VISA
- 6. Eligibility Certificate / No Objection Certificate from Indian Embassy.
- 7. Proof of date of birth

2.0 PAYMENT OF FEE

On receipt of allotment order, the candidate has to pay the prescribed fee immediately in the form of **Demand Draft only in US dollars** drawn in favour of **"The Finance Officer, TANUVAS, Chennai" payable at Chennai or through wire transfer.**

Note: For each extended year of study, an additional fee of US \$ 3,000 p.a. will be charged.

2.2. Development fee

One time development fee of **US \$ 2000** shall be paid at the time of admission for each degree programme.

The above prescribed fee should be paid in US dollars only from the active Foreign National account of the candidates / their parents. Payment of fee in any other currency and through any other account is NOT ACCEPTED.

2.3. Other regular fees

Tuition fees, special fees, examination fees, boarding and lodging fees etc., should be paid either in Indian rupee or its equivalent in US Dollars at the time of admission or when required to be paid as per the rules of the University.

Fees including institutional economic fee and development fee once paid are not refundable

2.4. Fitness

Candidates have to submit a medical fitness certificate at the time of final allotment as per Annexure II.

3.0 GENERAL INFORMATION

3.1 Reporting to the University

Candidates selected for admission are required to report to the Dean of the college concerned on the scheduled date mentioned in the allotment order. If the candidate fails to do so, the offer of admission will automatically stand cancelled.

3.2 Hostel Accommodation

Limited hostel accommodation is available inside the campus. Interested candidates may apply to the Dean of the campus for hostel accommodation. They have to pay the prescribed fee as

per hostel Rules. There is no separate hostel for students of Foreign National. The hostel mess runs on dividend system.

- **3.3.** All admissions shall be deemed as provisional and subject to further scrutiny. They shall be liable to cancellation at any stage during the study if it is found that an admission is contrary to the rules or invalid by reason of incorrect or false information furnished by the applicants or their parents/guardians at the time of admission. Any cancellation of admission shall not exclude penal action under the relevant criminal law.
- **3.4.** Tamil Nadu Veterinary and Animal Sciences University reserves the right to cancel or vary any of these rules without any prior notice.

4. PREVENTION OF RAGGING

RAGGING IS PUNISHABLE AS PER PROCEEDINGS OF HON'BLE SUPREME COURT OF INDIA IN SLP (C) NO. 24295/2004 CONVEYED BY THE UNIVERSITY GRANTS COMMISSION VIDE LETTER NO.F.1-8/2006 (CPP-II) DATED: 04.03.2008

If any incident of ragging comes to the notice of the authority, the concerned student shall be given liberty to explain and if his/her explanation is not found satisfactory, the authority would expel him/her from the Institution.
