1. ADMISSION REQUIREMENTS

1.1. Application Form

The candidate should fill, upload necessary documents / certificates and submit applications online at https://adm.tanuvas.ac.in from 26.05.2025, 10:00 AM IST to 27.06.2025, 5.00 PM IST. While applying online, the candidates are requested to give their order of campus preference for BVSc & AH which will be considered for Online counselling. After submission of application, the campus preference (BVSc & AH) cannot be negotiated. Hence, the candidates are requested to opt their preference of campus carefully before submission.

There is **NO NEED TO SEND THE HARD COPY OF APPLICATIONS TO THE UNIVERSITY**. However, the candidates may take the print out of the application for their reference.

Only online application will be accepted, other formats will be summarily rejected.

1.2. Eligibility

Applicants must be Non-Resident Indians (NRIs) / wards of Non-Resident Indians (NRIs) or NRI Sponsored candidates.

NRI status of applicant / parents / sponsorer (as applicable)

(Ref.: OI-11011/01/2017-OIA-II dated 19.05.2017 of the Director, OIA-II division, Ministry of External Affairs, Government of India, Chankyapuri, New Delhi)

- Non-Resident Indian (NRI) is an Indian citizen staying outside India for more than 182 days in a year.
- Candidates applying under NRI / wards of NRI / NRI Sponsored category should submit recent NRI status certificate of the Candidate / Parent /Sponsorer issued by the Indian Embassy of the Country concerned with their seal as per Specimen-I or I (a) as applicable.
- > An Overseas Citizen of India (OCI) Cardholder / Person of Indian Origin (PIO) have been granted parity with the NRIs in the field of Education. Necessary proof should be submitted along with the application.
- Overseas Citizen of India (OCI) Cardholder will not be considered under Foreign National category for educational purposes vide Ref.: OI-11011/01/2017-OIA-II dated 19.05.2017 of the Director, OIA-II division, Ministry of External Affairs, Government of India, Chankyapuri, New Delhi.
- > Overseas Citizen of India (OCI) Cardholder / Person of Indian Origin (PIO) who have foreign passports / Indian passports will be considered as NRI only in the field of Education.
- NRI and wards of NRI must submit a certificate from the competent authority in Specimen I.
- NRI sponsorer must submit a certificate from the competent authority in Specimen I (a).
- NRI who is financially supporting the candidate <u>must be a blood relation</u> such as father / mother / brother / sister / uncle (Own brother of father or mother) / aunt (Own sister of father or mother) only (Relationship certificate from competent authority needs to be produced in Specimen II).

1.3 Academic Qualifications

Eligibility for admission to BVSc & AH / BTech (Food Technology)

Candidates are **required to have studied in English Medium in the qualifying examination** and passed HSC (10+2) /CBSE / Other examinations recognized as equivalent there to, and obtained a pass with good marks / grades / as per their system of education in "Biology (or Botany and Zoology), Physics and Chemistry" for BVSc & AH and "Biology, Mathematics, Physics and Chemistry" for BTech (Food Technology), in 11th and 12th of School Education.

Only academic qualification examination marks secured by the candidate will be considered for the aggregate mark calculation. **Grace marks for co-curricular / extracurricular marks will not be considered.**

1.4 Age limit:

Minimum

Candidates should have attained the age of 17 years as on 31st December, 2025.

Maximum

Candidates applying for the degree programmes should not have completed the **21 years of age as on 01-07-2025.**

RELAXATION OF MINIMUM AND MAXIMUM AGE LIMIT IS NOT PERMISSIBLE ON ANY GROUNDS

1.5. Application Fee

During filling of online application form, the candidate has to make online payment of application fee of US \$ 30 (Thirty US Dollars only) for each course through Credit cards / Debit cards / Internet Banking / IMPS / UPI.

PAYMENT BY ANY OTHER MODE WILL NOT BE ACCEPTED

1.6. Last date for submission of Online application

The last date for submission of online applications and uploading of all necessary enclosures is on or before 27.06.2025, 5.00 PM IST. The cut-off date for eligibility of qualification is the last date for submission of application. All the necessary certificates / documents must be uploaded in online mode only.

If any of the required certificate is not enclosed, the application will be summarily rejected. Enclosures not received along with application will not be accepted at all.

1.7. Selection of candidates

The aggregate marks in the qualifying examination will be computed as detailed below:

A common Entrance Examination will be conducted for NRI or Wards of NRI or NRI sponsored candidates for admission to BVSc & AH and BTech (Food Technology) degree programme. Thus, 50% of the aggregate marks obtained in qualification examination (as detailed above) and 50% of the marks obtained in the common Entrance Examination will be considered for selection for admission to the respective degree programmes. The syllabus for entrance examination will be equivalent to HSC / CBSE / other equivalent examination. The provisional selection list will be hosted in the website - https://adm.tanuvas.ac.in. In case of a tie in the common merit list, the inter-se-merit among such students will be determined in the order of priority as specified below:

BVSc & AH

- Percentage of marks obtained in Biology (or Zoology and Botany taken together)
- Percentage of marks in Chemistry
- Percentage of marks in the optional subject
- ❖ Date of birth: seniority in age will be given preference

BTech (Food Technology)

- Percentage of marks in Mathematics
- Percentage of marks in Biology
- Percentage of marks in Physics
- ❖ Date of birth: Seniority in age will be given preference

1.8. Original Documents to be submitted at the time of admission by the candidates belonging to NRI / Wards of NRI Categories

- 1. Recent NRI status certificate of the candidate / parent issued by the Indian Embassy of the Country concerned with their seal as per Specimen-I as applicable.
- 2. Employment Certificate of the NRI parent as per Specimen-III. In the case of self-employment, nature of business, annual income and proof thereof.
- 3. Proof of updated / recent NRI / NRE / NRO Bank account (last six months) of the Parent.
- 4. Original passport to be produced for verification along with photocopy of the Passport of the NRI candidate /NRI parent
- 5. HSC (10+2) or Equivalent Examination mark list of the candidate. If grades are produced, certificate showing equivalent marks to grades obtained from competent authority should be submitted. In addition, for those candidates who have appeared HSC examination of Tamil Nadu State Board from March 2019 onwards, a pass in 11th standard examination is mandatory (G. O. Ms. No. 195, School Education Dept., Dated: 14.09.2018 of the Government of Tamil Nadu).
- 6. Certificate showing that the candidate has undergone the qualifying school education in **English medium**.
- 7. Transfer Certificate / Migration Certificate issued by the Head of the Institution last studied
- 8. Proof of Date of Birth of the candidate
- 9. Proof of Place of Birth / Nativity certificate
- 10. Conduct Certificate issued by the Head of Institution last studied
- 11. Medical Fitness Certificate from a Registered Medical Practitioner, not below the rank of a Civil Surgeon
- 1.9. Original documents to be submitted at the time of admission by the NRI sponsored candidates

 NRI Sponsorer should be either candidate's own Brother / Sister / Uncle (own brother of father or mother) / Aunt (own sister of father or mother)
 - 1. Recent NRI status certificate of sponsorer sponsoring the candidate issued by the Indian Embassy of the Country concerned with their seal as per **Specimen-I** (a) as applicable.
 - 2. Relationship certificate showing the relationship of the sponsorer to the candidate as per **Specimen-II**
 - 3. Employment Certificate of the sponsorer as per **Specimen-III**. In the case of self-employment, nature of business, registration, tax returns, annual income and proof thereof

- 4. Proof of updated / recent NRI / NRE / NRO Bank account statement (last six months) of the sponsorer
- 5. Photocopy of the Passport of the NRI sponsorer
- 6. HSC (10+2) or Equivalent Examination mark list of the candidate. If grades are produced, certificate showing equivalent marks to grades obtained from competent authority should be submitted. In addition, for those candidates who have appeared HSC examination of Tamil Nadu State Board from March 2019 onwards, a pass in 11th standard examination is mandatory (G. O. Ms. No. 195, School Education Dept., Dated: 14.09.2018 of the Government of Tamil Nadu).

- 8. Transfer Certificate / Migration Certificate issued by the Head of the Institution last studied
- 9. Proof of Date of Birth of the candidate
- 10. Proof of Place of Birth / Nativity certificate
- 11. Conduct certificate issued by the Head of the institution last studied
- 12. Medical Fitness Certificate from a Registered Medical Practitioner, not below the rank of a Civil Surgeon
- 1.10 The syllabus for the Entrance Examination is hosted on the university website. The details of the entrance examination pattern, exact date, time and venue of the Entrance Examination for the NRI / wards of NRI / NRI sponsored candidates will be intimated later on the University website.

2.0 PAYMENT OF FEE

In case of selection and receipt of the allotment order, the candidate has to pay the prescribed fee immediately in the form of **Demand Draft only in US dollars** drawn in favour of "**The Finance Officer, TANUVAS, Chennai**" payable at Chennai or through wire transfer.

Note: For each extended year of study, an additional fee of US \$ 3,000 p.a. will be charged.

2.2. Development fee

One time development fee of **US** \$ 2000 shall be paid at the time of admission for each degree programme.

The above prescribed fee should be paid in US dollars only from the active NRI/ NRE account of the NRI candidate / NRI parents / NRI sponsorers as mentioned in the application. Payment of fee in any other currency and through any other account is NOT ACCEPTED.

2.3. Other regular fees

Tuition fees, special fees, examination fees, boarding and lodging fees etc., should be paid either in Indian rupee or its equivalent in US Dollars at the time of admission or when required to be paid as per the rules of the University.

Fees including institutional economic fee and development fee once paid are not refundable

2.4. Fitness

Candidates have to submit a medical fitness certificate at the time of final allotment as per **Annexure-II.**

3.0 GENERAL INFORMATION

3.1 Reporting to the University

Candidates selected for admission are required to report to the Dean of the college concerned on the scheduled date mentioned in the allotment order. If the candidate fails to do so, the offer of admission will automatically stand cancelled.

3.2 Hostel Accommodation

Limited hostel accommodation is available inside the campus. Interested candidates may apply to the Dean of the respective campus for hostel accommodation. They have to pay the prescribed fee as per hostel Rules. There is no separate hostel for NRI students. The hostel mess is run on dividend system.

3.3. All admissions shall be deemed as provisional and subject to further scrutiny. They shall be liable to cancellation at any stage during the study if it is found that an admission is contrary to the rules or invalid by reason of incorrect or false information furnished by the applicants or their parents/guardians at the time of admission. Any cancellation of admission shall not exclude penal action under the relevant criminal law.

3.4. Tamil Nadu Veterinary and Animal Sciences University reserves the right to cancel or vary any of these rules without any prior notice.

4. PREVENTION OF RAGGING

RAGGING IS PUNISHABLE AS PER PROCEEDINGS OF HON'BLE SUPREME COURT OF INDIA IN SLP (C) NO. 24295/2004 CONVEYED BY THE UNIVERSITY GRANTS COMMISSION VIDE LETTER NO.F.1-8/2006 (CPP-II) DATED: 04.03.2008

If any incident of ragging comes to the notice of the authority, the concerned student shall be given the liberty to explain and if his/her explanation is not found satisfactory, the authority would expel him/her from the Institution.
